Emma Hughes, a student in the Agri-Science Program, and Ian Zuchowski, a post grad student, spoke to the Committee about their positive experiences throughout their participation on the team.

# **ORAL REPORTS:**

#### 1. School Committee:

Mr. White reported on the Narragansett Parks & Recreation Advisory Board meeting held on November 14, 2016 at which they discussed melanoma prevention and the importance of sunscreen. The Advisory is looking into installing sunscreen dispensers in various locations at Narragansett Town Beach.

## 2. School Reports:

Narragansett Elementary School: Ms. Dandurand, Principal of Narragansett Elementary School reported that coaches and Principals have shared PARCC data with all grade levels and are working with all grade levels to compact curriculum so that all concepts are taught by the end of the year. Principals are monitoring the implementation of guided reading and math workshops. NES is a Title 1 school and is required to have a parent informational night with Title 1 families only, which took place last week and was well attended. NES 4th grade students were interviewed for PBIS Ambassadors leadership positions. Students must demonstrate that they follow PBIS expectations of safety first, expect respect, and act responsibly. The ambassadors help with: hallway safety during entry and dismissal; collecting *caught being good* tickets; making posters for our good deeds dress up days; and special events such as the holiday bazaar and the mock election. NES teacher, Mrs. Lindsay Phillips, helps coordinate this program for NES. The 4th grade students are very much enjoying their Chromebooks! Other grades have either laptops or iPad to share by grade levels. The NES team has been working with the FUSE fellow on Professional Development and met last month to discuss topics such as: curation of technology materials, digital citizenship, and future PD for staff. Ms. Dandurand attended (along with our district Administrators) a Blended Learning PD hosted by Chariho. Educators from all around the state gathered to share ideas. The NES PTO is hosting a Family Bingo on Friday night in the NES Cafeteria. Ms. Dandurand thanked the PTO for providing this fundraising activity.

Narragansett Pier School Ms. Kirby reported that the first quarter has closed and report cards went home on Monday. Ms. Kirby was very pleased to report that over 100 seventh and eighth grade students were eligible for the honor roll. PARCC data review team work is under way with Administrators and coaches facilitating conversations with teachers to use data in instruction to improve student achievement. Math teachers spent time with catalyst teacher Ms. Carolyn Mellor sharing their best practices using technology. NPS will host the RI State qualifier for First Lego League on Saturday, December 17th. The event is open to the public at noon. Winter sports tryouts are underway for girls' and boys' basketball and wrestling. Cheerleading tryouts will begin in December. The Pier School Boosters will host a the 16th annual basketball tournament on December 2nd and 3rd at the Pier School. Grade 8 went to the Trinity Rep's *The Christmas Carol* this week; grade 7 will attend the play on December 1.

Auditions for The Little Mermaid Jr. will be on November 28, 29, 30 and December 1. The show is scheduled for March 10, 11 and 12. 110 students have signed up for auditions or for tech crew. The 7th and 8th grade chorus will be singing at the State House on November 30th, at the Festival of Lights on December 4. The NPS winter concert is on Thursday, December 8th with the band concert at 6:30pm and the strings and chorus at 7:30pm in the high school auditorium. Other dates of note: picture re-takes on Friday, December 2; PTO meeting on Monday, December 5 at 7pm in library.

Narragansett High School Mr. Toby Gibbons reported on the NHS November 2016 Highlights and happenings: 11/2 Flu Clinic for Staff and students; 11/3 Picture Retakes; 11/10 Blood Drive; 11/15 Guidance Advisory Meeting; 11/17 Financial Aid Night; 11/19 Mariner Marketplace; 11/22 Freshman and Junior Class Dodgeball Tournament; and on 11/29 Parent Conferences begin 4-7 PM. Michaela Degnan, signed a letter of intent to University of Arkansas; Winter sports sign-up starting; and the Art Club begins again.

<u>Special Education</u> Ms. Brow, Director of Student Services, invited the Committee to the ALP Program's Annual Thanksgiving lunch on Thursday at 12PM at NHS.

3. **Superintendent's Report:** Dr. Cummings reported that he is conducting "Entry Interviews" with interested staff, parents and people in the Narragansett community. The response has been very good and he has been able to learn a lot about the District in a short period of time. Dr. Cummings will use the information he gathers from these meetings in the Strategic Plan.

Dr. Cummings reported that NHS had a visit from RIDE about the Information Technology strand. Many thanks to Dan Warner, Toby Gibbons and Chris Hertz. They will be rendering a decision and we should be notified sometime in mid-December about approval of this program.

The Narragansett School System has posted the Director of Technology position and will begin interviews in December. Mr. Roland Lambert, Director of Technology, will retire at the end of December and he hopes to have someone in place by January 2017.

Dr. Cummings encouraged the public to attend the Winter Concerts December 7<sup>th</sup> NHS and the 8<sup>th</sup> at NPS; he acknowledged both the NHS Boys & Girls soccer teams making it into the playoffs this season; and he noted NHS senior Michaela Degnan's official signing for a swim scholarship.
